Description of the PPE:

A jacket and trouser set made in navy blue woven fabric, waterproof membrane of yellow non-woven with white coating, yellow non-woven insulating layer and grey woven lining: the two inner layers are quilted. Both garments have 7,5 cm and 5 cm wide, retro-reflective bands in grey in the centre and fluorescent yellow at the edges, segmented and thermosealed. The 7,5cm bands are on the back and around the torso, arms and legs, the 5cm bands are on the pockets and front of the jacket.

The materials that form the PPE, are described in the conformity assessment report nº 2021CO1815UE.
